**Location**

Chicago, Illinois, USA

**Venue**

The Center on Halsted is the 65,000 square foot community center devoted to service the LGBT community in the City of Chicago. For MIR 20, we have reserved the entire third floor of this state of the art facility including the gymnasium, black box theater, dressing rooms, reception hall, locker rooms and outdoor terrace overlooking Chicago's Boystown neighborhood.

**EVENT HISTORY**

In 1997, Roger Hickey and David Boyer created the Mr. International Rubber contest to support the fledgling US rubber scene. Since that time the contest has seen steady progress to become a truly international event and contest weekend.

Mr. International Rubber celebrates 20 years of growth and launches MIR past the half way mark in it's second shiny, sleazy, and sweaty decade of rubbery indulgence. In 2009 the contest was purchased by two members of the rubber community under a new entity, MIR Contest, LLC. MIR 20 is the eighth contest under the new ownership and will honor the traditions of Mr. International Rubber while working to expand the offerings of this fun filled weekend

## CONTESTANT ENTRY RULES

Each contestant in the Mr. International Rubber contest:

1. must be male and at least eighteen years old by the date of the contest;
2. must have a demonstrated interest in rubber/latex, BDSM or fetishes as determined by the judging panel;
3. must agree to appear onstage wearing appropriate rubber/latex and fetish gear and participate in all judged categories while conforming to local regulations pertaining to nudity and obscenity. For the purposes of this contest, testicles and penis must be covered at all times and a minimum one inch strip of material must cover the anus at all times;
4. must own all rubber/latex clothing worn onstage during the contest, with the exception of props used during the "Rubber Fantasy" segment;
5. must agree to represent the Mr. International Rubber title, if he wins, throughout his title year and refrain from competing in any other leather/rubber/fetish contest until the conclusion of his Mr. International Rubber title year;
6. must agree to permit on-stage photographs to be taken of him for use on the Mr. International Rubber website or related publications and promotional activities;
7. there is no preliminary contest requirement to enter the Mr. International Rubber contest and contestants may be self-sponsored. However, contestants are encouraged to secure sponsorships by relevant clubs, businesses or individuals to assist them in their pursuit of the Mr. International Rubber Title.

Contestants should arrive in Chicago and at the contest venue no later than 12:00 pm (Noon) on Friday November 4, 2016 with copies of completed application and should appear in person at all scheduled events during MIR weekend through Saturday, November 5, 2016 at midnight.

Contestants are strongly encouraged to arrive on Thursday afternoon/evening and to depart no sooner than Monday morning. This allows you time to decompress on either side of the contest and compensates for any possible travel delays/conflicts.

## CONTESTANT DEADLINES

**REQUIRED - Deadline for contestants for MIR 20 is 12:00 pm (Noon) on Friday, November 4, 2016.**

Contestants should bring (**not stapled or bound**):

**8 copies** of the completed application (pages 9-11)

**8 copies** of a photo of yourself in rubber gear printed on 8 ½ x 11 paper (or similar size)

**Above materials will be placed in the judges' binders**

**one** copy of their **typed** 150 word maximum Rubber Fantasy, min. 12pt font (page 12)

**one** copy of the signed release (page 13)

**photo identification** (driver's license or valid passport)

to the weekend registration area promptly at 12:00 pm on Friday, November 4, 2016

### EXPECTATIONS OF THE WINNER

- The winner of the title MIR 20 is required to attend and judge the Mr. International Rubber 21 contest, to be held in Chicago approximately one year following their victory.
- As the winner of the title, their primary responsibility is to 1) promote the international rubber fetish scene, 2) the Mr. International Rubber contest as part of the international rubber scene, and 3) to promote and acknowledge the companies that have provided prizes that accompany the title.
- As part of their sponsorship agreement, MIR 20 sponsors are afforded priority scheduling for MIR 20 to appear at their events. This agreement does not require or obligate MIR 20 to place an undue financial burden on himself to attend those events. Each appearance request requires negotiation of terms for both the requestor and MIR 20 to come to some suitable arrangements.
- Finally, MIR 20 is strongly encouraged to attend additional leather and rubber fetish events whenever possible to promote the international rubber scene, the Mr. International Rubber Contest as well as promoting and acknowledging the companies that have provided the prizes that accompany his title. He should use his best judgment as to which events will benefit him and the title the most.
- MIR 20 should maintain regular and frequent contact with Mr. International Rubber event staff to assist in planning and promotion and to provide regular updates on [www.MIRRubber.com](http://www.MIRRubber.com)

### PRIZE PACKAGE

The prize package for winners is different each year and dependant on donations from vendors and supporters of Mr. International Rubber. The preliminary prize package will be listed on [www.MIRRubber.com](http://www.MIRRubber.com) in the weeks prior to the contest, but will not be finalized until shortly before the contest.

Any monetary prize awarded to Mr. International Rubber from the contest owner is awarded in two installments. The first installment is made immediately following the contest and consists of half of the monetary prize. The second installment is awarded upon successful completion of the title year and returning to participate in the selection of his successor. The failure to appear at the contest to select your successor will result in the waiving of any additional monetary prize that may be awarded or due from MIR Contest, LLC at that time by the individual.

**PRELIMINARY CONTESTANT SCHEDULE\***

**Friday November 4, 2016:**

**12:00 pm Contestant Meeting**

Final deadline for contestant applications to be submitted and contestants meet with the contestant wrangler, weekend coordinator and contest owner to review weekend schedule, contest rules, and expectations of the winners. Judges will also be present for socializing.

\*Final Contestant Schedules will be provided at this time, and is subject to change.

**7:00 pm Meet and Greet Cocktail Party**

Contestants must attend. At approximately 8:30 contestants will be taken backstage for final contest preparations.

**9:00 pm Mr. International Rubber 20 Contest - Part 1**

Judges and contestants are introduced to the audience and contestants select their order of competition. The contestants are judges in the first two categories of competition- "Rubber Image" & "Rubber Fantasy".

**Saturday November 5, 2016:**

**12:00 pm Contestant Interviews**

All contestants will be required to assemble and remain in a holding area throughout the interview process.

**7:00 pm Contestant Call**

All contestants will assemble for final preparations and contest.

**9:00 pm Mr. International Rubber 20 Contest - Part 2**

Contestants will be judges in the onstage "question", "mystery-bag" and audience participation portions of the contest.

## CONTESTANT WEEKEND PACKAGES

It is not necessary for contestants to purchase an MIR Weekend Package, however anyone traveling with a contestant will be required to purchase a weekend package or individual tickets if they are going to participate in MIR Weekend events. Each contestant will receive a badge that will allow him access to all events.

## INTERPRETERS

If you do not verbally speak and understand English, you must bring an interpreter with you and they must attend all official events and rehearsals along with you. MIR does not have the ability to provide interpreters for all contestants in need.

If you cannot bring an interpreter, please contact Craig Neumann via [wrangler@mirubber.com](mailto:wrangler@mirubber.com) prior to October 1, 2016 for possible assistance.

Your interpreter will be given a badge that authorizes them to be with you at all times. Bring your interpreter with you to weekend registration to receive their interpreter badge.

## BACKSTAGE ASSISTANT

Contestants are not allowed personal assistants back stage during the contests. The Contestant Wrangler staff as well as fellow contestants are there for assistance. Space back stage is limited and for security purposes of contestant's gear, we will limit access to the contestant area to authorized persons only.

## FRATERNIZATION WITH JUDGES

Mr. International Rubber contestants are encouraged to get to know the judges and interact with them. However, contestants shall be prohibited from having private meetings or engaging in sexual activity or scene play with the judges prior to the announcement of the results.

To avoid accidental violation of this policy, and possible removal from the contest, all contestants and judges should display their identification badges at all times.

## WEEKEND PARTICIPATION

Contestants are strongly encouraged to participate in the weekend events. The Mr. International Rubber Contest is all about having a good time and promoting the rubber fetish scene. Contestants are judged throughout the weekend by both judges and attendees reflecting in their final contest scores. This year, contestants will be offered a scheduled time during the Rubber Market hours, if they wish, to participate in a featured demo so that audience members may get to know them better.

**CONTEST JUDGING METHOD**

A panel of seven (7) judges representing leaders in the international rubber/latex community scores Mr. International Rubber contestants. Judging is made in five (5) categories using a combined Olympic scoring system in the categories and points outlined below. The contest also involves one audience choice component which is added to the judge's scores.

**Interview – (maximum 1000 points, up to 200 points per judge, Olympic scoring)**

Each contestant will meet with the judging panel offstage and in private, prior to the contest to answer questions about the contestant's interest in rubber, BDSM, fetishes, knowledge, willingness and ability to represent the title. Interviews will last no longer than 10 minutes each. Therefore it is important to listen to the question being asked by the judges and respond in a concise and complete manner so that all judges have a chance to ask questions of the contestant. If the judges would like to know more, they will ask for additional information.

**Rubber Image – (maximum 500 points, up to 100 points per judge, Olympic scoring)**

Each contestant will appear onstage and be introduced to the audience by the Emcee using information provided on the completed contestant application. Judging in this category is based on how you present yourself as a "rubberman."

**Rubber Fantasy – (maximum 500 points, up to 100 points per judge, Olympic scoring)**

Each contestant will appear on stage to act out their rubber fantasy that they have **typed** in the application and read by the emcee. Judging in this category is based on the contestants' creativity and ability to convey the sensual and sexual nature of the rubber fetish. Contestants are allowed to utilize one additional person (previously selected) on stage with them along with any props (approved prior to competition) that they can carry on stage and off when they are finished. Contestants are allowed to provide their own music to be played during the reading of their fantasy but will not include an intro or play beyond the reading of the **typed** maximum 150 words. If Contestants do not provide their own music, a selection will be played by our audio engineer.

(NOTE: The fantasy is to be **typed** (page 12 of application), a maximum 150 words and turned in at the Friday noon contestant meeting. If contestants provide their own music, it must be in MP3 or MP4 format, mailed via CD or emailed **30 days prior** to competition.)

**Onstage Question – (maximum 500 points, up to 100 points per judge, Olympic scoring)**

Each contestant will answer a question onstage. Judging in this category is based on how well you can command the audience's attention as well as how well you respond to the question.

**Mystery Bag - (maximum 500 points, up to 100 points per judge, Olympic)**

Each contestant will come onstage to select one mystery bag from local Chicago shopping destinations. Inside each bag are several "non-fetish" items, which the contestant must find some creative use for in a fetish scene. Judging in this category is based on a contestant's creativity, knowledge of safe play practices and spontaneity.



### **Audience Vote - (Maximum 100 points total, spread across all contestants, non-Olympic)**

Audience members will assist in the selection of Mr. International Rubber by casting a ballot for the individual they believe should be Mr. International Rubber. Points will be awarded based on the percentage of the total votes that each contestant receives. (IE: Contestant "A" receives 50 votes out of 200 total cast and thus receives 25 points from the Audience Vote.)

In the Olympic scoring system, the high and low score for each contestant and in each category, is discarded. The remaining scores are totaled for each contestant. The audience vote is added to the judges' total for the final score. The contestant whose aggregate score is highest will be declared the winner. The contestant whose scores are second and third highest will be declared the first and second runner-up respectively.

In the event of a tie under the total scoring system, the Audience Vote category will be eliminated and results re-tabulated to determine a winner.

In the event there are only four contestants, only a winner and first runner up will be declared and have prizes awarded.

In the event of any dispute regarding the tallying of the contest, MIR Contest, LLC shall make the final determination of the winner.

## **CONTESTANT SUGGESTIONS**

The Mr. International Rubber Contest and Rubber Weekend are all about having a good time, socializing with fellow fetish community members and promoting the rubber fetish.

Contestants are encouraged to participate in weekend activities to be seen as an active member of the fetish community. We try our best to allow contestants enough free time to participate and be seen during the weekend while fulfilling the requirements to produce a contest.

The MIR contest, and the weekend have been created to have a great time. We encourage the contestants to have fun and entertain the audience to set this contest apart from many others. We encourage you to work the audience and judges so that you will stand out on stage.

During the contest, contestants are encouraged to demonstrate different rubber fetish looks representing the different judged categories. Time is scheduled during the contest to allow contestants time for gear and look changes. Assistance is available from the Contestant Wrangler staff or help from fellow contestants.

Make sure that you come prepared with back up outfits and gear in case accidents or blow-outs happen. Bring your own lube and shine materials and remember to clean up after yourself.
